### STRUCTURAL ASSESSMENT REPORT

NAME OF THE WORK: Existing Building of Lalitha Public School, Wardhaman Nagar, Ring Road, Nagpur. 440035.

As per the request of Management of the above subjected school, I visited the above said premises 10.06.21, to assess the Structural Safety of the building. The said building is a Ground plus three storied RCC framed structure & was constructed in 2006-07.
