STRUCTURAL ASSESSMENT REPORT

NAME OF THE WORK: Existing Building of Lalitha Public School, Wardhaman Nagar, Ring Road, Nagpur. 440035.

As per the request of Management of the above subjected school, I visited the above said premises today, to assess the Structural Safety of the building. The said building is a Ground plus three storied RCC framed structure & was constructed in 2006-07.

The following are the observations –

1. The structure is in good condition & Maintained properly.
2. No settlement is observed anywhere.
3. Floor is in good condition, no settlement is observed.
4. Structural arrangement has not been changed at any location.
5. Three RCC Over Head tanks of approx. 10,000 ltrs capacity are seen in good condition.
6. Non destructive testing has been carried out at major locations. The results of the testing are satisfactory.

Based on the observations, I am of the opinion that, **the building is safe for the purpose it is intended.**
